Codiga Center & Museum: John Kegebein reported work was being done on new ID signs for the milk bottle exhibit.

Archives: Sheila Prader reported the advisory committee had a successful meeting. She is working on brewery research for a panel for the hops display.

Gift Shop: Jennifer Lemon showed two of the new finger puppets that have arrived in time for Day on the Farm, an alpaca and a red squirrel. Her goal for Day on the Farm is \$600 in the gift shop.

Motion to accept the Nominating Committee's slate of officers for 2014-15 was made by Rosemarie Imazio; seconded by Tom Rider and approved by the board. It proposes a 10 year lease with 2 10 year options; they will send requested revisions to DGS. The hope is to have a lease for approval at the July meeting.

Motion to approve the Marketing Committee recommendation to contract with Lindsey Roberts for the marketing activities outlined in her May to December 2014 proposal was made by John Eiskamp; seconded by Dennis Howell and approved by the board. The signage design proposal was referred to the Marketing Committee for evaluation.

CEO Report: CEO Kegebein reported on the tour he conducted for the UCSC Life Long Learners group. The Madonna Grange is restarting and is interested in partnering with AHP on a Living History Farm. John reported he will be on vacation in June.
